## Object: Regulation (EC) No 1907/2006 – REACH

Concerning the REACH regulation (EC No 1907/2006), we declare that **Vibac Spa** has transposed and is applying the regulation according to the ways and times set out by the norm itself.

According to art. 3, par. 1, (point 33) **Vibac Spa** is designed as:

*“supplier of an article: every manufacturer and/or importer and/or downstream user in a supply chain of a substance or any other actor which introduces an article in the market”;*

as articles manufacturer and dealer, according to regulation (EC) 1907/2006, art. 3, par. 1, (point 3).

*“article: an object to which, during the production, is given a special shape, surface or design, which determines its function more than its chemical composition.”*, We are final user of the substances/preparations used for the production of the articles we sell to You, therefore we will continue to request updates to our suppliers about the substances that we purchase, according to the specific use that is made of it in VIBAC.

European legislation on chemicals (REACH Reg. EC 1907/2006) does not mention the requirement for a manufacturer of articles, in contrast to what is required for a manufacturer of chemicals or chemical compounds, to provide safety data sheet. Furthermore, it has the obligation to inform the final user in the case the article itself contains a substance considered "problematic" (SVHC).

**We confirm that in the articles You buy from us is not intentionally used/added any of the substances listed in SVHC (“Substance of Very High Concern”) list updated to 15/01/2019, with the exception of the Electrical 290, which contains DEHP (2-ethylhexyl) phtalate – CAS n 117-81-7, in 20% weight/weight amount.**

**Anyway the DEHP is not released by the article in normal use or in reasonable and foreseeable conditions.**

In May 2011, the presence in Electrical 290 of a substance included in the candidate list (DEHP) was notified to the European Chemicals Agency (ECHA), since DEHP is present in Electrical 290 at a concentration higher than 0,1% weight/weight.

Although DEHP is classified in the EU as Substance of Very High Concern, consumers can be confident that its use in everyday products does not represent a risk for human health.
