in relation to the provisions of the **delegated Directive (EU) 2015/863 of the COMMISSION of 31 March 2015 amending Annex II to Directive 2011/65/EU of the European Parliament and of the Council with regard to the list of substances with restrictions of use**

we declare that:

articles produced by Vibac S.p.A. comply with the directive in question, which constrains the use of substances that we report in the table below and that these substances are not intentionally introduced * at any stage of the production processes.

*: "Intentionally introduced" means: "deliberately utilised in the formulation of a material or component where its continued presence is desired in the final product to provide a specific characteristic, appearance or quality"

Diisobutyl phthalate (DIBP)	0,1% of weight on homogeneous material*	(1g/Kg – 1000 ppm)

* that means a unit that can not be mechanically broken into several separate materials. Can not be considered as homogeneous materials: electronic components, enameled glass, components or plated, coated or painted parts.

 ** with the exception of Decabromodiphenyl oxide (CAS 1163-19-5)
